Clerk advised that the loss of the General Power of Competence did not operate retrospectively.

The aim is to rejuvenate a tree that appears to be in decline. T3 - Cherry - Overall crown reduction of 1.25m.  TM/23/00715/FL - Single storey extension to commercial building to be used for bottled water storage. Hawk Spring Water Victoria Road Golden Green Tonbridge Kent TN11 0LS

Hadlow Parish Council does not object in principle to the proposed extension of this property as proposed. However, we are concerned that the current parking arrangements may not comply with the existing consent and that the proposed additional parking may be excessive in the circumstances. We are also concerned that the extension may result in a more intensive use of the property resulting in increased HGV traffic on/off the site. Finally, we are concerned that the proposed screening should also deal with the apparent loss of previous screening in previous years.

 TM/23/00742/LDP - Lawful Development Certificate Proposed: Erection of a detached outbuilding in rear garden for storage/office/gym. 34 Carpenters Lane Hadlow Tonbridge Kent TN11 0EJ

Hadlow Parish Council strongly objects to this planning application. The application appears to request consent for unlawful development which has already been built on the site, which we have repeatedly objected to and is presumably currently subject to enforcement action. The existing temporary consent is also the subject of an Appeal to the Secretary of State, so in our view this further application is inappropriate at this time until that Appeal has been determined.
